#### NUMBER OF BOROUGH COUNCILLORS TO BE REDUCED AND FEWER OPPORTUNITIES TO VOTE.

At the council meeting in November it was decided to reduce the number of councillors from 60 to about 42 to 48. We Liberal Democrats agree with that. It was also decided by Labour and Conservatives to replace the present system of voting for some councillors 3 years out of 4; from 2018 you will be voting every 4 years. We disagree with that, since it reduces too much the opportunity for the public to show views about the group running the council. Under current law, put in place under the previous Labour government, it is not possible to change to having elections every 2 years.

Residents have contacted us about the muddy verges across the ward. Marion has asked the County to find solutions, such as more plastic bollards. Please do not allow contractors or others to park on grass verges.

#### **COOMER COURT and GREENOCK CLOSE**

After much pressure by residents and your Liberal Democrat councillors, the roads and pavements by these new houses have been properly surfaced by the developer; it was long overdue.
